OPEN-ENDED WORKING GROUP ON AGEING (OEWGA) 12th session, 11-14 April 2022

The meeting will take place <u>in person and virtually</u>. 1. Organization of work (https://undocs.org/A/AC.278/2022/CRP.1)

The first day of the twelfth session will have two three-hour meetings for procedural matters and General Discussion, while the interactive discussions on day 2 and 3 will have two two-hour meetings per day. On the fourth day, the discussion on the way forward will be a two-hour meeting in the morning, while the afternoon meeting will be three hours for procedural matters and closing of the twelfth session.

2. In-person attendance

Representatives of registered A-status National Human Rights Institutes or an ECOSOC accredited NGO (with or without an active grounds pass) or an NGO with previous accreditation to the OEWGA, <u>who</u> <u>plan to participate in person</u>, must register here: <u>https://www.surveymonkey.com/r/oewg12-registration</u>. **DEADLINE is 5 APRIL 2022**.

3. Virtual connection

Panelists have been invited to participate in person or virtually in the interactive discussions. Other speakers making oral statements online will be advised of connection details when they submit their oral interventions in writing (see below).

4. Making an ORAL statement on a specific agenda item

Participants wishing to make oral statements are requested to submit the text of their <u>oral</u> <u>interventions</u> in Microsoft Word format to eStatements (estatements@un.org) well in advance of the meeting <u>but no later than two hours before delivery, clearly indicating:</u>

5. General Discussion on Day 1

6. <u>Time limit for oral interventions and video statements</u>

The time limit for oral interventions and video statements delivered by representatives of "A" status National Human Rights Institutions (NHRIs) and Non-Governmental Organizations with ECOSOC Status and accredited organizations to the Open-ended Working Group on Ageing is <u>three (3) minutes (this is</u> <u>equivalent to a maximum of 375 words in English).</u>
